<p>INDICATIONS Dry skin accompanied by itching (xeroderma in the elderly/adults, dry skin in children)</p>	<p>DOSAGE AND ADMINISTRATION Apply an appropriate amount to the affected area once to several times daily.</p> <p><Precautions></p> <ol style="list-style-type: none"> (1) Be careful not to get the medicine into the eyes. If the medicine gets into the eyes, immediately wash with water or lukewarm water. If symptoms are severe, consult an ophthalmologist. (2) For children, use under parental guidance. (3) For external use only. (4) Clean the affected area and surrounding skin before use. (5) Follow the prescribed dosing instructions. (6) As this is not a cosmetics, use only for the affected areas listed in the indications, and do not use on the face for the purpose of basic skin care, etc.

Consultation

- (2) Persons with a history of allergic symptoms (e.g. rash, redness, itching, contact dermatitis, etc.) or irritation symptoms due to any drug

2. The following symptoms may be adverse reactions to the medicine. If any of these symptoms occur, discontinue the use of the medicine immediately, and consult a physician, pharmacist or registered salesperson with this leaflet.

Skin	Contact dermatitis, rash, redness, itching, irritation (pain, feeling hot, tingling sensation), swelling, scab-like skin exfoliation

3. If symptoms do not improve after using the medicine for about two weeks, discontinue the use of the medicine, and consult a physician, pharmacist or registered salesperson with this leaflet.
